OPEC, for valuable and good consideration, will lease you one of the following Oliver Model 1208, 1308 or 1908 heat sealers to package your meals on the terms and conditions set forth below

Customer responsibility:

- Model 1208 - Minimum 40 meals per day. (blanket purchase orders accepted) _____
- Model 1308 - Minimum 75 meals per day. (blanket purchase orders accepted) _____
- Model 1908 - Minimum 500 meals per day. (blanket purchase orders accepted) _____
- Pay inbound shipping and handling charge on leased heat sealer net 30 days.
- Purchase OPEC supplied paper or plastic heat sealable trays and film at the minimum levels
- Complete credit application (subject to approval by OPEC)
- Term of leased equipment shall continue as long as customer purchases OPEC supplied trays/film wherein OPEC recovers your lease payment as part of the consumable purchases. Customer to return leased equipment within 15 days upon ceasing to use OPEC supplied trays/film.
- Customer is responsible for all unused trays/film upon ceasing use of leased heat sealer as well as freight costs necessary to return equipment to OPEC.
- Customer to notify OPEC with heat sealer concerns by calling 1-800-253-3893 24 hours per day, 7 days per week.
- Customer shall obtain and maintain property insurance covering the leased equipment and shall name OPEC as an additional loss payee.
- Customer, where applicable, shall pay personal property taxes on leased equipment per taxing authority.
- Maintain reasonable care of heat seal equipment. Reasonable care consists of regularly following the maintenance steps listed in the machine manual and maintenance checklist. In cases of misuse or abuse to leased equipment as determined and documented by OPEC, repairs may be charged to customer.

OPEC responsibility:

- Purchase price for paper or plastic trays according to the current Senior Meals price lists
- Trays/film shipped F.O.B. delivered; fewer than 8 case orders, subject to freight charges (other terms and conditions apply) - Payment Terms are net 30 days
- OPEC shall retain ownership and all right, title and interest in and to the heat seal equipment. OPEC shall repair and maintain leased heat seal equipment at OPEC's expense when the machine has been kept in reasonable care.
- OPEC shall provide user friendly set up instructions for the 1208 and 1308
- OPEC shall set up and train staff on the 1908
- All shipments are subject to OPEC's Terms of Sale provided on order acknowledgements
